# **CALL MEETING TO ORDER**

President Shatter called the meeting to order at 5:01 PM. A quorum was declared with all members present.

President Shatter introduced new Town Manager, Susan Guthrie, who spoke a little about herself.

## **DISCUSSION / ACTION ITEMS**

1. DISCUSS AND CONSIDER APPROVAL OF THE REGULAR MEETING MINUTES FOR JANUARY 16, 2019.

Treasurer Bochniak made a motion to approve the January 16, 2019 regular meeting minutes with changes. Seconded by Vice President Weeks. President Shatter called for a vote. All voted in favor. The motion passed unanimously.

2. DISCUSS AND CONSIDER THE JANUARY 2019 FINANCIAL REPORTING, AND RELATED FINANCIAL ITEMS.

Finance Assistant Phyliss Moore presented the January 2019 financials. Treasurer Bochniak made a motion to approve the January 2019 financials as reported. Seconded by Member Korah. President Shatter called for a vote. All voted in favor. The motion passed unanimously.

3. DISCUSS AND CONSIDER SUNNYVALE DAY AT THE CAPITOL AND EVENT BUDGET.

President Shatter stated that the 4A paid for the last Sunnyvale Day at the Capitol and that Economic Development Director Traci Anderson wanted to Board to provide a budget on what they would spend on the event as it is currently not a budgeted item. Member Korah motioned to approve adding a miscellaneous expense in the amount of \$3,000 for the event. Seconded by Secretary Cash. President Shatter called for a vote. All voted in favor. The motion passed unanimously.

4. DISCUSS AND CONSIDER 2018-2023 ECONOMIC DEVELOPMENT STRATEGIC PLAN.

Economic Development Director Traci Anderson presented the ED Strategic Plan and asked for any feedback to be provided by the end of the month.

Member Korah stated he spent some time reviewing the Plan and had a few suggestions: On page 3, there are 5 bullet points for goals and feels this might not capture the whole spirit of intent. He feels that some of the goals listed are more plans vs goals. He feels the following should be included in lieu of current goals. He stated he pulled information from different websites from some research he did.

- Economic Diversification should be Develop and support Entrepreneurial ecosystem Increased Commercial Tax base and more local job opportunity. He feels that might be already implied in 1st bullet point.
- -Tourism and Parks and Trail should be Strong Quality of life Need to add:
- Strong social capital. IE-events such as Octoberfest etc
- Human investment-IE partnering with schools, colleges to attract workforce needs
- Dedication to progress -IE such as commitment to supporting investment and current businesses

Atmos not allowing CFA to build their parking lot now over their easement is what has caused a replat. CFA has to shift their building over. They are still planning to come to Sunnyvale.
