CERTIFICATION OF HOUSE-POOL PROTECTION DEVICE INSTALLATION

I certify that I the homeowner at: _____, and that one of the following swimming pool protection devices have been/will be installed between all doors leading from the house and the garage into the swimming pool area at or before the pool final inspection.

_____ 1. All doors with direct access to the pool are equipped with an alarm that sounds continuously for at least thirty (30) seconds, after the door is opened. It must be capable of providing audible warning level capable of being heard throughout the house during normal household activities. The alarm shall automatically reset under all conditions and be equipped with a manual means, to temporarily deactivate the alarm for a single opening. The deactivation device shall be located at least 54" above the threshold of the door.

_____ 2. All doors/gates leading to the pool are equipped with self-closing and self-latching devices installed with the release mechanism located a minimum of 54" above the floor (**electrical power gates do not meet the requirements**). These devices shall be subject to approval by the Town of Sunnyvale. These devices will be acceptable so long as the degree of protection afforded is not less than the protection afforded by item 1, above,

Prior to receiving final inspection of the pool, all permanent fencing requirements must be met. Permanent fencing requirements are outlined in the swimming pool permit and inspection requirements information packet.

The undersigned contractor and owner further certify that during construction of the pool, no right-of-way or streets will be blocked with vehicles, dirt, or sand, unless approved by the Building Official and Public Works Dir. The contractor will have to provide a traffic layout for review and approval.
